ORDER OF REINSTATEMENT TO THE BAR OF THE COURT


Before the Disciplinary Panel is the application of Jim Salvator, seeking reinstatement to the bar of the court under D.C.COLO.LAttyR 11(b). On September 8, 2020, the Chair for the Committee on Conduct, Thomas S. Rice, filed with the court a unanimous recommendation of the Committee that the Disciplinary Panel grant Mr. Salvator's petition for reinstatement from disability inactive status. The Disciplinary Panel agrees with the Committee that Mr. Salvator has satisfied the requirements for reinstatement under D.C.COLO.LAttyR 11(b)(4) by demonstrating that he is no longer disabled and is fit to practice law. Having reviewed the Chair's recommendation letter and other pertinent documentary evidence on file, the Disciplinary Panel concurs with the Committee's recommendation.

It is therefore




