ORDER OF REINSTATEMENT TO THE BAR OF THE COURT

Before the Disciplinary Panel is the application of James S. Oliver Jr., seeking reinstatement to this Court's bar under D.C.COLO.LAttyR 11(b). On April 19, 2021, the Chair for the Committee on Conduct, Thomas J. Overton, filed with the court a unanimous recommendation by the Committee that the Disciplinary Panel grant Mr. Oliver's petition for reinstatement without conditions. The Disciplinary Panel agrees with the Committee that Mr. Oliver has satisfied the requirements for reinstatement under D.C.COLO.LAttyR 11(b) by offering of clear and convincing evidence of his rehabilitation from the disability that led to his reciprocal suspension under D.C.COLO.LAttyR 10(b). Having reviewed the Chair's letter of recommendation and all other pertinent documentary evidence on file, the Disciplinary Panel concurs with the Committee's recommendation that Mr. Oliver is no longer disabled and is fit to practice law.

It is therefore

ORDERED that James S. Oliver Jr. is reinstated to the practice of law before the United States District Court for the District of Colorado under D.C.COLO.LAttyR 11(b)(4) and reinstated without any conditions imposed under D.C.COLO.LAttyR 11(b)(5).
