ORDER OF REINSTATEMENT

Before the Disciplinary Panel is the application of Mary Jaclyn Thompson (formerly known as Mary Jaclyn Cook) seeking reinstatement to the bar of the court under D.C.COLO.LAttyR 11(a)(3). On December 4, 2019, the Chair for the Committee on Conduct, Thomas S. Rice, filed with the court a unanimous recommendation of the Committee that the Disciplinary Panel grant Ms. Thompson's petition for reinstatement to the court's bar without imposing any conditions under D.C.COLO.LAttyR 11(a)(6). Having reviewed the Chair's letter, and other pertinent documentary evidence on file, the Disciplinary Panel concurs with the Committee's recommendation.
