ORDER OF REINSTATEMENT TO THE BAR OF THE COURT

Before the Disciplinary Panel is the application of Robert E. Abrams seeking reinstatement to the bar of the court under D.C.COLO.LAttyR 11(a)(3). On December 21, 2020, the Chair for the Committee on Conduct, Thomas J. Overton, filed with the court a unanimous recommendation of the Committee that the Disciplinary Panel grant Mr. Abrams's petition for reinstatement. The Disciplinary Panel agrees with the Committee that Mr. Abrams has satisfied the requirements for reinstatement under D.C.COLO.LAttyR 11(a)(3), by an offering of clear and convincing evidence. Having reviewed the Chair's recommendation letter and other pertinent documentary evidence on file, the Disciplinary Panel concurs with the Committee's recommendation.

It is therefore

ORDERED that ROBERT E. ABRAMS is reinstated to the practice of law before the United States District Court for the District of Colorado pursuant to D.C.COLO.LAttyR 11(a)(3).




