ORDER OF REINSTATEMENT TO THE BAR OF THE COURT

Before the Disciplinary Panel is the application of Robert Jason Herrera, petitioning the Court under D.C.COLO.LAttyR 11(a)(3) for reinstatement to the bar. On March 17, 2023, the Chair for the Committee on Conduct, Brooke H. Meyer, filed with the Court a unanimous recommendation of the Committee that the Disciplinary Panel grant Mr. Herrera's petition for reinstatement. Having reviewed the Chair's recommendation letter and other pertinent documentary evidence on file, the Disciplinary Panel concurs with the Committee's recommendation. The Disciplinary Panel agrees with the Committee that Mr. Herrera has satisfied the requirements for reinstatement under D.C.COLO.LAttyR 11(a)(3) by offering clear and convincing evidence of his rehabilitation and fitness to practice law.

It is therefore


