
Before the Disciplinary Panel is the application of Derry Dale Sadler seeking reinstatement under to D.C.COLO.LAttyR 11(a). On September 21, 2018, a letter from the Chair for the Committee on Conduct, David P. Hersh, was filed with the District Court and forwarded to the Disciplinary Panel, recommending that the application of Mr. Sadler for reinstatement to the bar of the court be granted, subject to compliance with the probationary terms imposed by the Presiding Disciplinary Judge of the Supreme Court of Colorado, William R. Lucero. Having reviewed the Chair's letter and documents filed in support of the application, the Disciplinary Panel fully concurs with the recommendation of the Committee on Conduct in finding that the standards for reinstatement set forth in D.C.COLO.LAttyR 11(a)(3) have been satisfied.


It is therefore


