ORDER OF REINSTATEMENT


Before the Disciplinary Panel is the application of Gabriel Stefu seeking reinstatement under to D.C.COLO.LAttyR 11(a). On March 16, 2018, a letter from the Vice Chair for the Committee on Conduct, Suneeta Hazra, was filed with the Court and forwarded to the Disciplinary Panel recommending that the application of Mr. Stefu for reinstatement to the bar of the District Court be granted, without conditions. Having reviewed the Vice Chair's letter and documents filed in support of the application, the Disciplinary Panel concurs with the recommendation of the Committee on Conduct in finding that the standards for reinstatement set forth in D.C.COLO.LAttyR 11(a)(3) have been satisfied.

It is therefore

ORDERED that GABRIEL STEFU is reinstated to the practice of law before the United States District Court for the District of Colorado, without conditions.




