
Before the Disciplinary Panel is the application of Peter Kristopher Strojnik seeking reinstatement under to D.C.COLO.LAttyR 11(a). On November 3, 2017, a letter from the Chair for the Committee on Conduct, David P. Hersh, was filed with the Court and forwarded to the Disciplinary Panel recommending that the application of Mr. Strojnik for reinstatement to the bar of the District Court be granted. Having reviewed the Chair's letter and documents in support of the application, the Disciplinary Panel concurs with the recommendation of the Committee on Conduct in finding that the standards for reinstatement set forth in D.C.COLO.LAttyR 11(a)(3) have been satisfied.

It is therefore

ORDERED that PETER KRISTOPHER STROJNIK is reinstated to the practice of law before the United States District Court for the District of Colorado, subject to compliance with all probationary conditions set forth in the document styled Terms of Probations. Additionally, in the event of a violation of any probationary condition, particularly urinalysis testing, Mr. Strojnik is to ensure that his compliance monitor is authorized to inform this court directly of such violation.


