The hotels listed are conveniently located in the Denver downtown area. Effective January 1, 2017, jurors who reside 50 miles or more (one-way) from the courthouse have the option to stay overnight in a local hotel and may receive the applicable meals and incidental expense rate each day of service. The current hotel reimbursement rate is posted at www.cod.uscourts.gov under the Juror Information tab.

Jurors are responsible for making their own hotel accommodations. Some hotels offer a government rate for federal jurors who show their jury summons as proof. Facilities with mandatory resort/amenity fees and the like should be avoided. The use of online booking sites and accommodations such as Airbnb and VRBO are strongly discouraged due to rigid cancellation policies. If used, jurors do so at their own risk of not being fully reimbursed should a trial or grand jury session end early. Jurors are expected to check-out on the last day of service.
