I had to move pods because my cellmate began to treat me and differently the next day, intimidation ating me, Telling me not to move off my bunk. I let classifications Know about the situation. I via the inmate Kiosk "Kite" system" Deputy Neyhart Violated my Failure to Protect under the Eighth Amendment by telling Everyore I was Gay. Since this incident occurred the Avapahol County Sheriff Investigated the incident, and on 11-5-2020 they did Find Evidence that Deputy Neybart made the Comment, but felt it was a Joking manner. I recently submitted a avievance on 12-25-2020 for retaliation also. Deputy W. Neyhart refused to give me toilet paper, and I was was forced to wipe my bottom with my underwear. This also has been documented. I live daily in Fear now of this officer. My anxiety is so high around 5pm, because I'm in such flar of him working in my Pod. It's Psycological, and emotional wantave.


