CLAIM ONE: Special Administrative Measures (SAMs) imposed on me violate my constitutional rights

Claim one is asserted against these Defendant(s):
Warden Gollij Counselor Hollorooks; Merrick Garland; Colette Peters

### Supporting facts:

I am a Mexicah national, who was extradited from Mexico to the U.S on January 2017, to face multiple criminal charges. Following a 3 month trial in the EDNY, I was found guilty and on July 17,2019, I was sentenced to life in prison. I was then transferred to USP Florence ADMAX, where I am when thy incarcerated.

Since my extradition, I have been and continue to be under the SAMs (Special Administrative Measures). Since I was extradited more than seven years ago, the American government has kept me in solitary confinement without being able to speak to anyone and under SAMs. I am not permitted to have any verbal contact or communication with other inmates.

The then Attorney beneral of the U.S. (back in 2017) requested the imposition of the SAMS on me and said that it was necessary to restrict my access to the media, mail, telephone, visitors (essentially to restrict my access to the world). The government claimed that there was a risk that my contact with other people could result in death or injury to others, or that I could continue conspiring to commit additional annihal activity to

The SAMs resenct my access to mail, telephone, media, visitors, and limit my recreation and exercise time. The SAMs violate my right to associate with the community. They sake defendants, by imposing the SAMs on me, are violating my right to family integrity by severely prestricting my ability to maintain relationships with my family, and the right to family integrity is angult that is recognized in the U.S. Constitution and protected by International human rights law.

However, the CAN's imposed on me are not specific to me. In fact, many of the measures imposed on me by the governmentscem designed for a defendant charged with terrorism related offenses.

The operations allegations in the SAMs, perpetuate the myths and legends that have currended the for years. But the government has never offerred any concrete examples of violence toward witnesses or continued criminal activity while in custody.

I have behaved in an exemplery mamer in the years that I have been incorrectated in the VS.

The defendants have not provided sufficient justification to public safety to continue subjecting meto these conditions of confinement.

The SAMs isolate me as much as a person could be isolated inside a prison and severy limit my communication with the world. The measures have devastated my relationship with my family in every way.

I have not been able to speak to my unife since 2017. I am not longer allowed to speak to my other sister, Armidas, since speak to my sister. I have not allowed to speak to my other sister. Also, According to ADMAX Admission and Onentation Handbook, at p. 18, a variety of educational programs and opportunities are offered at the facility. Some of these programs are Adult Basic Education, General Equivalency Diploma, and English as a fecond Language. English classes are important to me, because I want to learn it. Only by learning English I are important to me, because I want to learn it. Only by learning English I can avail myself of other programmatic services, and basic education classes.

Almost all education at ADMAX consists of self-directed study in one's cell, by watching pre-rewided visions on the in-cell to. There are channels for educational programming, thowever, the channels broadcast in English only, and therefore, I cannot understand anything that is being said.

I have made repeated requests to Defendant Willi, Defendant Italbrooks and BOP staff at ADMAX to a Johns this situation, but nothing has been done and therefore, I cannot participate in any of these programs.

According to the ADMAX Admission and Orientection Handbook, at p. 18, Hear immate has the right to a "vide variety of reading materials for educational purposes". I wish to take advantage of some of these programs. However, Defendants and their agents are depriving me of my right to participate in these programs by refusing to provide Spanish translations or subtitles.

For example, English as a Seword Language is one course offerred to inmates at ADHAX. Some my arrival to ADMAX, I have requested personally and through my lawyer to be enrolled in ESL course. BOP staff members and Defendant Holbrooks told my lawyer that enrolled in ESL course. CLAIM THREE: Defendants violated my Eight Amendment Right to Medical Care and to humane and safe conditions

Supporting facts:

I have asked multiple times to Defendant Colli, Defendant Holbrooks and Bol staff at ADMIAX to be seen by an ENT (ear, nose and throat specialist) to treat an allergy that I have had for over 3 years now and it won't go away and my ears, nose and throat are constantly har ting. The medical department has given me medicine for it, but it doesn't work. I have purchased over the counter medicine for it, but it doesn't work either. At this point, I need a medicine at the commissary, but it doesn't work either. At this point, I need a specualist to see me. I have told the patendants through copoutand through specualist to see me, my attorney about this issue, and we have requested for a specualist to see me, but Defendants have ignored my requests. I have tried to use the Administrative Remedy Brogram regarding this issue, but Defendants and BOP stoff at ADMAX have made it impossible for me to pursue this path.

For example, I started a giverance process forthis issue. On February 8th of 2024, I finally submitted a Central Office Fernady Appeal (BP-11) form, but I have yet to receive a response (I attached this BPII form as groof). Quite frankly, I don't think I will get a response either, its I never got responses for the BP-9 or BP 10 either.

I am suffering from severe sleep de privation as a result of being woken up repeatedly throughout the night, every night by this hotair. This is concerning because I have been treated for high blood pressure, a well-known symptom of sleep de privation. This ailment, in turn, could also increase the risk of a heart attack or a stroke. And beyond these physical effects, I have been experiencing depression and memory hors, which are also symptoms of nevere sleep depression.

Defendants are violating my Eight Amendments Rights to safe and humane conditions and are subjecting me to unel and inusual principment. The governmentacks, with deliberate indifference when it knowingly express an individual in its justidy to a substantial fist of senous ham. The Defendants here know of the risks of senous horm that theyo are subjecting me but are disvegarding those risks by failing to take reasonable measures to a bate it.

## CLAIM FIVE: Defendants are violating my Eight Amendment Rights to medical Care and safe and humane bonditions by Refusing to for me to get treated by a mental Health professional

Supporting facts:

Defendants have made me want up to five weeks to speak to someone from the mental health department at ADMAX. I have no access to group therapy. Therefore, I have no one to help me uppe with the effects and trauma of solitary confinement. Defendant Colli and Defendant Holbrooks and BOR Staff at ADMAX have ignored all of my requests for regular visits from a mental Health professional.

All the prisoners at ADMAX are visited regularly by someone from the psychology department, except me. I have not seen a mental health professional in over a department, except me that someone from the mental health department has come year, and the few times that someone from the mental health department has come year, and the visit doesn't last more than five minutes.




