

#### CLAIM ONE: Sexual Abuse 8<sup>th</sup> Amendment Constitutional Violation

Claim one is asserted against these Defendant(s):Raven Saccamanno

Supporting facts: Centennial Correctional Facility Fremont County

During the fourth week of June 2024, Officer Saccamanno called Harvey to pick up food trays from A trough H. After the food trays were taken to the kitchen, officer Saccamanno asked Harvey to clean empty cells in two restrictive housing units. Officer Saccamanno and Officer Filer walked into H-B pod. While Harvey followed Saccamanno up the stairs to B-205, officer filer stayed at the bottom of the stairs. Harvey started spraying cleaning chemicals to the bunk area. Harvey approached Saccamanno and just how many cells need to be cleaned? Officer Saccamanno then placed her right hand causing Harvey to have an erection. Harvey asked what are you doing. Saccamanno replied, relax we won't get caught I've done this before. Saccamanno pulled the front of Harvey's pants down, and started masterbating his penis. Harvey said no, and pulled away from Saccamanno. Harvey did not ejaculate during this occasion. See incident report Exhibit 1802206. C.O. filer was at the bottom of the stairs when Harvey walked out of the cell. Officer Saccamanno Violated 8<sup>th</sup> amendment prohibiting cruel and Unusual punishment, constituting the unnecessary, and wanton infliction of pain. This unwanted touching of Harvey's private parts, which was reckless and callous indifference to the federally protected right's of Harvey. This was intended to humiliate Harvey, being medically incontinent. This gratification of Saccamanno's sexual desire did violate Harvey. Per intel, Harvey was not authorized by job board to work in the vestibule area. Exhibits ccf form 650-03c (8\20) and grievances R- cf - 23\24 002566651. Harvey was only authorized to work in H-E pod. Prea investigation was opened 9\16\2024 by Major T. Vogan and closed by O.I.G. Brown on 9\24\2024. See EXHIBIT. Harvey was denied Prea Victim advocate present during medical examination. See EXHIBIT 268295. Harvey request compensatory and punitive damages for the acts and omissions in this complaint, and for emotional pain and suffering. Under Penalty of Perjury, the complaint is truth under law, and this is a verified complaint.


