**DISTRICT COURT GENERAL ORDER
2020-2**

WHEREAS, the Governor of the State of Colorado has declared a state of emergency in response to the spread of COVID-19 (coronavirus); and

WHEREAS, the Centers for Disease Control and Prevention, the Colorado Department of Public Health and Environment, and the Denver Department of Public Health and Environment have advised taking measures as to slow the spread of the disease and precautions to reduce the possibility of exposure to the virus; it is hereby

ORDERED by the United States District Court for the District of Colorado that, effective immediately, all civil, criminal petit, and grand jury selections and jury trials scheduled to commence now through April 3, 2020 before any district or magistrate judge in any courthouse in the District of Colorado are CONTINUED pending further order of the assigned judicial officer.

The Court also provides notice to litigants, attorneys, and the public that the Court's judicial officers, to the extent practicable and at their discretion, will endeavor to reschedule hearings or to convert hearings to telephonic appearances in an effort to minimize the need for persons to travel to court, understanding that certain hearings may nevertheless require personal appearances.

**AMENDED STANDING ORDER REGARDING CIVIL PROCEEDINGS
FOR MAGISTRATE JUDGE NINA Y. WANG
(Effective March 16, 2020)**

As of March 13, 2020, the State of Colorado is reporting additional cases of the novel coronavirus, COVID-19, signaling “limited community spread.” It appears that for the vast majority of people, consequences will be limited to flu-like symptoms. But for some, it can pose a serious risk including death. Though the business of the United States District Court for the District of Colorado and this judicial officer will continue, in order to support public health efforts to cabin the spread of the coronavirus and to protect the health of the Parties and counsel by minimizing their need to travel as well as the general public, the following measures are adopted in an abundance of caution. Accordingly, **IT IS ORDERED THAT:**

- (1) All proceedings scheduled between March 16, 2020 up to and including April 7, 2020, except for criminal proceedings, are hereby **VACATED** and will be **RESET** pursuant to further Order of the court.

Parties and/or counsel are advised to check information on the website of the United States District Court for the District of Colorado (www.cod.uscourts.gov) and specifically, for Magistrate Judge Wang for continuing information.
